LIMITED FIVE - YEAR WARRANTY

NON TRANSFERABLE

CLOSET DOORS DEPOT's guarantees its mirror products to be free of defects in material and workmanship for five (5) years from the original date of purchase. This warranty extends to the original purchaser and the first consumer-owner only. If a product fails due to defects in material or workmanship during the warranty period, we will, at our option, repair it or replace it with the most nearly identical product which we sell at the time. **CLOSET DOORS DEPOT** will not be liable for any labor charges or freight costs incurred in connection with repair or replacement of a product.

This warranty does not cover:

1. Damage resulting from negligence, misuse, abuse or accident occurring after installation
2. Mirror breakage
3. Damage resulting from foreign matter in the bottom track, on the back or edges of the product
4. Loss of aroma from cedar wood backing (where applicable)
5. Damage due to outside normal architectural requirements or within six (6) miles of the ocean, or rust caused by atmospheric conditions
6. Defects resulting from any modification or installation made by anyone other than CLOSET DOORS DEPOT

CLOSET DOORS DEPOT's sole responsibility is as set forth above. IN NO EVENT SHALL CLOSET DOORS DEPOT, BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES.
